EXEMPTION OR REDUCTION OF NATIONAL HEALTH INSURANCE TAX

If you file an income tax return, your insurance tax may be reduced. If you are unable to pay the hospital due to the following reasons, you may be exempt from paying or may not have to pay.

Filing income tax return is very important for those covered by national health insurance.

- 1)-4) Apply at least 7 dyas before the tax payment deadline after you receive the tax payment notice.
- 5) Applications can be made from June each year

- 1) Those who are on welfare.
- 2) Those who have lost their jobs and experienced a significant drop in income.
- 3) Those who need to take a long break due to illness.
- 4) Those whose homes were destroyed by the disaster.
- 5) Those who is listed below.
 - a. Those who have a disability certificate (grade 1-3) (身体障害者手帳), progressive muscular atrophy up to grade 6, renal dysfunction p to grade 4
 - b. Those with IQ of 50 or less
 - c. Those who have been diagnosed with autism (自閉症候群)
 - d. Those who have a war injury certificate (戦傷病者手帳)
 - e. Those whose age of 18 or under among single-parent medical expenses recipients. For queries,
